Sharron Angle Apologizes To Shirley Folkins-Roberts And Her Husband

"It Is A Mistake Any Nevada Voter Would Make When Researching \$29,000 In Contributions To Democrats From A Republican Candidate For Secretary Of State. I Am Sorry"

Reno, Nevada - Sharron Angle Responds To Shirley Folkins-Roberts Cease & Desist: On April 1, Sharron Angle received a Cease and Desist demand from lawyers representing Shirley Folkins-Roberts, her opponent in the race for Nevada Secretary of State. While the records at the Nevada Secretary of State do confirm \$29,000 in contributions to Democrats over the last 7 years, a \$1,000 contribution to Aaron Ford was mistakenly included that should not have been.


Sharron Angle Apologizes To Shirley Folkins-Roberts And Her Husband: *"I absolutely want to apologize to Shirley Folkins-Roberts and her husband Doug Roberts publicly for mistakenly including Democrat Candidate for Governor Aaron Ford in the list of contributions they have made over the last 7 years, they did not. It was a mistake, as Shirley Folkins-Roberts' husband is listed as both DOUG and DOUGLAS in contribution reports, and the contribution to Aaron Ford is from a completely different "Douglas Lee Roberts". The commercial has been removed, it was a mistake, I stand corrected, and I am sorry," said Angle.*

7 Years, 6 Democrats, 4 Versions Of Names, 3 Different Addresses: *"According to the Nevada Secretary of State, Republican Candidate for Nevada Secretary of State, Shirley Folkins-Roberts and her husband made \$29,000 in contributions to 6 Democrats in the last 7 years. The reports have the contributions using 4 different versions of names and 3 different addresses. This includes **Mariluz Garcia - Washoe County Commission (\$2,500 in 2025), Devon Reese - Reno City Council (\$3,000 in 2020-2025), Alexis Hill Washoe County Commission (\$2,500 in 2023-2024), Hillary Shieve - Reno Mayor (\$6,000 in 2021-2022), Naomi Duerr - Reno City Council (\$5,000 in 2022), and Steve Sisolak - Governor (\$10,000 in 2018-2019).** Nobody is doing anything wrong, its most likely different checking accounts with different information, perfectly legal. It is a mistake any person or any Nevada voter would make when researching Shirley Folkins-Roberts' \$29,000 in contributions to Nevada Democrats. **Re: CEASE & DESIST/LEGAL DEMAND – FALSE CAMPAIGN
ADVERTISEMENT**

Dear Ms. Angle:

This Firm represents Ms. Shirley Folkins-Roberts, candidate for Nevada Secretary of State ("Ms. Folkins-Roberts"). We have conducted an investigation into your campaign's recent radio advertisement and have determined that your campaign has engaged in demonstrably false, misleading, and legally actionable conduct. Specifically, your campaign is currently airing a radio advertisement that falsely claims Ms. Folkins-Roberts and her husband, Doug Roberts, donated to Aaron Ford. This statement is categorically false, and your campaign's failure to conduct proper due diligence before broadcasting such claims to Nevada voters constitutes, at minimum, reckless disregard for the truth.

The factual record is unambiguous: the campaign contribution your advertisement references belongs to a Douglas Lee Roberts of Las Vegas—an entirely different individual who shares no relation to Ms. Folkins-Roberts or her husband. A cursory review of publicly available campaign finance records—the very records maintained by the Nevada Secretary of State's Office—would have revealed this distinction immediately. The donor's full name, address, and other identifying information clearly establish that Douglas Lee Roberts of Las Vegas is not Doug Roberts, Ms. Folkins-Roberts's husband.

Your misconduct constitutes, inter alia, defamation, false light, and violations of Nevada campaign advertising laws under NRS Chapter 294A. Nevada law prohibits the dissemination of false statements of fact in campaign advertising, and your reckless broadcast of fabricated claims about Ms. Folkins-Roberts's political contributions is precisely the type of misconduct these statutes are designed to address. There is no effective legal defense or justification for publishing demonstrably false statements about a political opponent, particularly when the truth was readily ascertainable through the most minimal investigative effort. Ironically, as a candidate for Nevada Secretary of State you are asking Nevadans to entrust you with the office that is responsible for maintaining campaign finance disclosures. Your lackadaisical failure to distinguish between two individuals in this database before defaming a fellow candidate on the airwaves, entitles Nevadans to question whether you are qualified to oversee such records for the entire state. This is not merely a political misstep; it is negligence dressed up as opposition research.

Accordingly, Ms. Folkins-Roberts hereby demands that you:

1. Immediately cease airing, broadcasting, or otherwise disseminating the radio advertisement containing the false claim that Ms. Folkins-Roberts or her husband donated to Aaron Ford, and direct all radio stations, media buyers, and distributors to pull the advertisement forthwith;
2. Immediately provide direct written communication and evidence to this Firm that you have undertaken specific, concrete steps to ensure the advertisement has been removed from all broadcast schedules and will not air again in any form;
3. Immediately issue a public correction and retraction acknowledging that the campaign contribution at issue belongs to Douglas Lee Roberts of Las Vegas—not Ms. Folkins-Roberts's husband—and apologizing to Ms. Folkins-Roberts and Nevada voters for disseminating false information; and
4. Preserve all documents, communications, and records related to the creation, approval, and distribution of this advertisement, as such materials may be relevant to subsequent legal proceedings.

You or your counsel are hereby directed to contact this Firm within five (5) days of receipt of this correspondence to provide proof of full compliance with the demands set out herein. If you fail to provide timely written confirmation of full compliance, Ms. Folkins-Roberts will be compelled to pursue all available legal redress in the Eighth Judicial District Court of Clark County, Nevada, or the United States District Court for the District of Nevada. This will include an application for equitable relief via a petition for preliminary injunction, accompanied by a lawsuit for monetary damages. If legal action becomes necessary, Ms. Folkins-Roberts will pursue the maximum amount of damages available under Nevada law, including, but not limited to, compensatory and punitive damages, attorneys' fees, costs, and any other relief the court deems just and appropriate. Given the willful and reckless nature of your campaign's conduct, punitive damages will be vigorously pursued.

Our investigation remains extant. Guide yourself accordingly.
